### 2010/2011 OFFICIAL RULES

- The season long non-refundable entry fee is \$250. Contestants may purchase multiple entries. Entries are non-transferable.
- Registrations and weekly selections will be accepted at Delaware Park, Dover Downs and Harrington Raceway starting August 20, 2010. The contest runs from Week 1 of the 2010/2011 Pro Football regular season through Week 17. The first game of the contest will be played Thursday, September 9, 2010. The last game of the contest will be played Sunday, January 2, 2011. No contest sign ups will be accepted on a Sunday during the Pro Football regular season for play that day. Sign ups will be accepted after 1:30 on Sunday for play starting the following football week.
- Once a Contestant registers for the contest, he or she will be issued a unique Contestant Number. That number is valid for the entire season.
- The Contest is based on picking winning teams against the contest point spread. Contestants must select six (6) teams per week, per entry. Contestants MAY NOT select both sides of a game.
- Contest winners will be determined by the total number of points accumulated during the 2010/2011 NFL regular season. Each winning selection will be credited as one point.
- First place: \$50,000; Second place: \$15,000; Third place \$10,000; Fourth place \$4,000; Fifth place \$1,000. There will also be four Stage prizes of \$5,000 each awarded to the Contestant picking the most winners during the time period. Stage 1: Weeks 1-4; Stage 2: Weeks 5-8; Stage 3: Weeks 9-12; Stage 4: Weeks 13-17.
- In case of a tie between two or more contestants for any position, the prize money will be added together and divided equally among the contestants involved in the tie. For example, if there is a two-way tie for First Place, the First and Second Place prizes will be added together, so the payout for each would be \$32,500 each and there would be no Second Place finisher. In case of a tie for a Stage Prize, the \$5,000 will be divided equally among the contestants involved in the tie.
- Contestants must submit their weekly selections to a Delaware Lottery Sports Book by 11 a.m. each Sunday, except when there are Thursday or Saturday games. If a contestant wishes to use a Thursday game, all their weekly selections must be submitted prior to the first Thursday game. If a Contestant wishes to use a Saturday game, all their weekly selections must be submitted prior to the first Saturday game. Any contestant who fails to submit valid weekly selections by Sunday 11 a.m. will be awarded zero points that week. **THIS TIME DEADLINE WILL BE STRICTLY ENFORCED. INITIAL \_\_\_\_\_**
- Cancellations: In the event an entire week of games are cancelled, rescheduled and listed on a rescheduled contest card then games will be counted in the contest. In the event that any game listed on the contest cards should have a starting time or site change, but not a date change the game will be counted in the contest. In the event of a game cancellation or postponement, that game must be played by Monday of that week to be considered action or contestant will be awarded zero points for that game.
- Valid identification must be presented upon registration and may be required upon submitting selections. Contestants may authorize a proxy to submit their selections. Contestants will be asked to select a unique team name to be used in displaying standings and results.
- Each week's selection card will have a computer stub. The computer-generated ticket will be the official record of a Contestant's selections. The Contestant is responsible for checking to make sure the selections and Contestant Number appear correctly on the printed ticket before leaving the window. Tickets will not be voided. In case of a dispute, the Contestant must produce this ticket. The Delaware Lottery is not responsible for mismarked stubs.
- After each stage and after the final winners are posted, a three (3) day verification period will occur. Any disputes with the contest and the results or prize allocation must be provided to Delaware Lottery in writing within this verification period. At the end of this time, the results will be declared official.
- Contest lines will be available each Wednesday morning. Current standings will be publicly posted on Tuesdays on the Delaware Lottery Website and at each Delaware Lottery Sports Book upon verification of the results.
- All contestants must be 21 years of age or older.
- All Delaware Lottery Sports Book Rules and Regulations apply to this contest unless otherwise stipulated.
- The Delaware Lottery reserves the right to make changes to the contest rules and format or cancel the contest at any time without notice.
- Any questions or disputes concerning the interpretation of these rules, or situations not covered by these rules, will be resolved by the Delaware Lottery in a manner deemed by them to be fair to all concerned and that decision shall be final and binding on all entrants.
- Delaware Lottery employees are not eligible to participate in this contest.
- Valid identification and social security number will be required to collect prizes. All prizes must be collected by January 2, 2012, or they will be forfeited.
